



## **Fridays on Vine Vendor Policy**

**Adopted May 20, 2010**

- Only Food Vendors will be allowed at Fridays on Vine.
- Tooele City Arts Council will obtain a Concessionaire License as the sponsoring organization of the event.
- Vendors must comply with all Tooele County Health Department regulations.
- There is no cost for the booth space, but vendors must pre-register.
- No more than two vendors will be allowed to sell the same type of food. (i.e. Only two snow cone vendors would be allowed at each event. Therefore the first two snow cone vendors to pre-register with the proper documentation will be the only two vendors of that type of food allowed at that concert.)
- Vendors will be assigned a specific 10 x 10 spot in the park.  
(unless a special request is made for a bigger spot)
- Vendors are required to supply all materials needed, and are responsible to clean up your area when completed.
- All vendors will be courteous to performers, and not cause any undo noise that would interfere with the performance.
- It is the vendor's responsibility to abide by all the State tax laws.

### **Steps to be a Food Vendor for Fridays on Vine**

1. Obtain a Temporary Food Stand Permit from the Tooele County Health Department (151 North Main Street, Tooele). Forms can be found online at [www.tooelehealth.org](http://www.tooelehealth.org). A permit is not needed if you will be selling prepackaged (at a factory) food and drinks.
2. Come to Tooele City Hall (90 North Main Street) Parks and Recreation or the Records office to register for a booth space. Tooele City Hall is open Monday-Friday 8 a.m. – 5 p.m. You must sign up for each day individually. Vendors will be required to show proof of Temporary Food Stand Permit from the Health Department.
3. Vendors must keep a copy of the signed application with them at all events.
