## **Mobile Food Business Check List**

1	. Register your business name with the State of Utah toll-free at (877) 526-3994 OR online at <a href="https://corporations.utah.gov/contactus.html">https://corporations.utah.gov/contactus.html</a>
2.	Register your business with the Utah State Tax Commission <u>www.utah.tax.gov</u> or toll-free at (801) 297-2200 OR (877) 662-4335
3	Pick up Business License Application from the Tooele City Recorder's Office, Suite 227 OR the Tooele City website: <a href="http://tooelecity.org/wp-content/uploads/2018/07/Business-License-Application-070318.pdf">http://tooelecity.org/wp-content/uploads/2018/07/Business-License-Application-070318.pdf</a> . Notarization is required for all applications. We have notaries in City Hall, however, if you have access to a notary, you can have the application notarized and then e-mail all documents to the e-mail above.
4.	Comply with all Health Department Regulations: Food Manager Certification, Food Handler Permits, Commissary, etc 151 N Main Street, Tooele, Utah. 5	Comply with Fire Department Regulations: If a fire inspection is required, they will contact you to schedule an inspection.
6	When the business license has been approved, pay the \$40 Business License fee in the Tooele City Finance Department, Suite 118. (Renewable every January/or every season)
7.	If you have a current business license from another City, please provide a copy of the business license, fire, and health department inspections. (These documents can be e-mailed as well). After reviewing the documents, a \$10 processing fee can be paid in the Tooele City Finance Department, then a Tooele City Business License will be issued.

When ALL Departments have completed their inspections, given approval, and fees are paid the business license will then be issued.
