RULES

- All performances must be appropriate for all ages (“G” rated)
- Performers will refrain from making drug, sexual, and political references during performances
- Attire for all performers must be modest
- Performance should be 60-90 minutes with no intermission
- Performers will provide their own equipment necessary for performance, including any necessary sound equipment
- Performers agree to the sale of merchandise during and after the performance, with no specific break during the performance for the sale of merchandise
- Tooele City will provide a 30 x 16 ft. stage and power for performance
- All ages are welcome to submit an application (performers under the age of 18 require a parent’s or guardian’s signature on the release form included in this packet)
- Tooele City and the Tooele City Arts Council retain the right to refuse any entry or terminate a performance for any reason
- Neither Tooele City nor the Tooele City Arts Council will be held responsible for loss or damage to personal property belonging to, or in the care of, the performers
- Neither Tooele City nor the Tooele City Arts Council will be held liable for any injury to performers during performances
- Tooele City and the Tooele City Arts Council reserves the right to audio/video all performances and all audio/visual recordings will be the sole property of Tooele City and the Tooele City Arts Council
