



Fridays on Vine Vendor Policy

Adopted May 20, 2010

- Only Food Vendors will be allowed at Fridays on Vine.
- Tooele City Arts Council will obtain a Concessionaire License as the sponsoring organization of the event.
- Vendors must comply with all Tooele County Health Department regulations.
- There is no cost for the booth space, but vendors must pre-register.
- Only one food vendor and one snack vendor will be allowed at each Fridays on Vine.
- Vendors will be ready to serve food by 6:00 pm. All vehicles must be off the grass by 5:30.
- Vendors will be assigned a specific spot in the park.
- Vendors will only be allowed to attend one Fridays on Vine each month in order to give all vendors an opportunity to participate, unless more dates are available. Vendors will be notified by email if selected to attend.
- Vendors are required to supply all materials needed, and are responsible to clean up your area when completed.
- All vendors will be courteous to performers, and not cause any undo noise that would interfere with the performance.
- It is the vendor's responsibility to abide by all the State tax laws.

Steps to be a Food Vendor for Fridays on Vine

1. Obtain a Temporary Food Stand Permit from the Tooele County Health Department (151 North Main Street, Tooele). Forms can be found online at www.tooelehealth.org. A permit is not needed if you will be selling prepackaged (at a factory) food and drinks.
2. Come to Tooele City Hall (90 North Main Street) Parks and Recreation to register for a booth space. Tooele City Hall is open Monday-Friday 8 a.m. – 5 p.m. Please mark each day you are available, but know you may only be selected for one day per month. Vendors will be required to show proof of Temporary Food Stand Permit from the Health Department.
3. Vendors must keep a copy of the signed application with them at all events.
